ENTRY PERIOD. The Gas Money Giveaway ("**Sweepstakes**") begins at 12:00 a.m. Eastern Time ("**ET**") on November 15, 2023, and ends at 11:59 p.m. ET on December 15, 2023 (the "**Entry Period**").

How To Enter.
